Sl. No.	The school is directed to ensure that :
1	The total number of sections for Bal Vatika is restricted to 06 (02 each for Bal Vatika I,II & III respectively). Further, the total number of sections for classes 1st to 10th shall be restricted to 14 only. The optimum number of the students shall be restricted to 40 in each section. Any further increase of sections shall be subject to specific approval of the Board on the basis of the request of the school as per affiliation bye law and availability of class rooms of 500 sq ft and greater in dimension.
2	The school has uploaded NOC issued on 08.03.2024 only for the affiliation to Middle class. School has not uploaded proper NOC from state Govt for senior secondary level. School is directed to obtain the NOC from competent authority of the state Govt for affiliation till senior secondary level and upload the same on SARAS portal within 03 months.
3	The computer lab is under sized and under stocked with only 36 computers seen during the IC video. School should have a minimum of 40 computer nods with net connectivity. School is directed to upgrade the computer lab with recommended infrastructure and size as per circular no 11/2022 and upload the compliance with video link within 03 months on SARAS portal.
4	CWSN facilities are not made available at each floors separately for boys and girls. Further, the CwSN toilets are arranged in regular small cubicles with narrow entrance and less space which is not suitable for smooth navigation and movement of wheelchair. School is directed to follow the circular no 05/2023 and re-arrange the CwSN toilets as per Board guidelines and upload the compliance with video link within 03 months on SARAS portal.
5	School has not placed proper, permanent and visible signage at all prominent places of the school building in compliance of rule 4.7.2 of the Affiliation Bye Laws. School is directed to place the permanent signage and upload the compliance with video link within 03 months on SARAS portal.
6	School shall ensure the mandatory training of its teachers from CoE, CBSE, Bhubaneshwar and shall upload the compliance on SARAS portal within 03 months.

Compliance of the above mentioned points shall be submitted within 03 months on the SARAS Portal. Failure to comply within the prescribed time shall invite financial penalty @ Rs. 50,000/- every month until compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII , as the case may be.

The approval of the Board as mentioned above, is subject to the following conditions:-

- The school shall be responsible for its genuineness of the documents/ data/ information uploaded by the school. In case of any discrepancies, action will be initiated against the school as per Affiliation Bye -Laws-2018.

- The school shall renew mandatory certificates from time to time.

- Concerned Regional Office is requested to create new email id of school as per direction issued by controller of examination. This E Mail ID is used for communication with CBSE only.

SUBJECT:-Extension of General Affiliation up to Senior Secondary Level.

This is with reference to school application on the subject cited above. In this connection, I am directed to convey the approval of the Board for Extension of General Affiliation as per details given below:-

Sl. No.	The school is directed to ensure that :
1	The school does not have CwSN facilities like ramp at the entrance, ramp/lift to access upper floors, separate CwSN toilets for boys and girls on every floor. One CwSN toilet for girls is seen which is a normal toilet converted into CwSN toilet. It is too small and narrow and there is no room for a wheelchair/walker to navigate. Thus the school shall construct ramp at the entrance, ramp/lift to access upper floors, separate toilets for CWSN, boys and girls on every floor with proper permanent signage as per norms of RPwD Act and guidelines issued by the Board within 3 months and submit compliance on SARAS with videography.
2	Boys urinals/toilet area is filthy/unhygienic. Hence the school is directed to maintain proper hygiene in the toilet area and submit the videographic compliance within 3 months.
3	The school does not have sufficient toilets for students and staff. Hence the school is directed to construct sufficient toilets for students and staff and submit the videographic compliance within 3 months.
4	The computer lab does not have proper infrastructure (no AC) The number of computers as mentioned in the IC report is not seen in the videography. As per circular No.10/2023, 01 (One) Computer System per 18 (eighteen) students with minimum of 40 computer systems must be available in computer Lab. Hence the school is directed to upgrade the lab as per SoPs issued by the Board and submit the videographic compliance within 3 months.
5	School has not maintained and upgraded Mathematics Lab and Composite Science Lab as per SOPs/recommended infrastructure and facilities communicated vide Circular No. 11/2022. Maths lab does not have permanent workstations. Some desks are joined together and make a temporary workstation. Composite lab does not have permanent workstations with water connection, piped gas supply on the demonstration table. Wooden tables are used as workstation which is not as per norms. There is no seating arrangement and Safety feature like exhaust fan, fire extinguisher and emergency exit in Composite lab. Hence the school is directed to upgrade the labs as per SoPs issued by the Board and submit the videographic compliance within 3 months.
6	Library is seen understocked. Reading space for students and there is no reading space for staff. As reported by IC, the accession register and books were not matching. No English newspaper was found in the library. Hence the school is directed to upgrade the library as per SoPs issued by the Board and submit the videographic compliance within 3 months.

Compliance of the above mentioned points shall be submitted within 03 months on the SARAS Portal. Failure to comply within the prescribed time shall invite financial penalty @ 50,000/- every month until compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII, as the case may be.

The above sanction is subject to fulfillment of following conditions:-

1. The approval is based upon the documents /data/information uploaded by the school online. The school will be responsible for its genuineness. In case of any discrepancies, necessary action will be initiated against the school as per Affiliation Bye -Laws-2018.
2. The school will follow the RTE Act, 2009 and instructions issued thereon by the CBSE/Respective State /UT Govt. from time to time. The school will also abide by the conditions prescribed, if any, by the State Government concerned.
3. The School is required to apply online for extension of affiliation along with the requisite fee and other documents as per Rule 10.3 of Affiliation Bye Laws.
4. The school should go through the provision of Affiliation and Examination Bye Laws and subsequent amendment therein as well as circulars and guidelines /instructions issued by the Board time to time and keep a copy there of for reference purpose and is also advised to regularly visit CBSE websites i.e., <http://cbseacademic.nic.in/> & <http://cbse.nic.in/> for updates.
5. The school is required to renew mandatory certificates from time to time.
6. The school shall be solely responsible for any legal consequences arising out of the use of school name/logo/society/trust or any other identity /activity related to running of school affiliated to CBSE. All legal expenses incurred by the Board, if any, arising out of these circumstances, shall be borne by the school.
7. The school shall not remove the documents and videography links in the mandatory disclosure section of its website.
