NOW THIS AGREEMENT WITNESSETH AS UNDER:

The lease shall be for a period of 30 years .

- 1. That the lessee shall pay a monthly rent of Rs. 1000/- (Rupees only) exclusive of property tax, electricity charges, maintenance charges and any other charges to the land lord on or before 1 day of every English Colander month without any default. The payment of monthly rent shall be witnessed by duly stamped receipt evidently payment of rent.
- A) The Lessee paid of Rs 30000 to the lessor as deposit, which is adjustable before the termination of the lease.
- b) The lessee paid 30000 months' rent as deposit to the lessor which is refundable at the time of termination of lease. (either a or b)

- f) That the lessee shall not carry on any illegal business or shall store any material prohibited under law. That the lessee shall not store any explosive material which may damage the schedule properly.


